



# Ninja Obstacle Fitness Challenge Competition RULES & REGULATIONS



## QUALIFYING & FINALS' RULES

- Heats:  
Youth Ages 9-14 as of January 1, 2019  
Youth ages 15-18 as of January 1, 2019  
Adults ages 19 & Up as of January 1, 2019
- Pre- Registration Info: \$20 fee ages 9-14, \$30 fee ages 15-18, \$30 fee Ages 19 & Up By July 10, 2019; includes Qualifying Run and 9 Gate Admission Ticket.
- \$5 charge per each attempt during practice times.
- Contestant can only enter or qualify for finals three times.
- No more than 20 contestants can be entered in a heat.
- Order of go will be based on luck of the draw.
- Only the top five contestants in each daily heat will qualify for the sunday finals.
- Contestants will have only five-minutes to practice or complete the qualifying course.
- Placings will be based on best completed course times. If no contestant finishes, the course placings will be based on how far the contestant got in the shortest amount of time.
- There is no entry fee for the finals.
- The top five youth finishers in age group (9-14) of the finals will receive the following:  
-> 1ST \$250, 2ND \$200, 3RD \$100, 4TH \$50, 5TH \$25
- The top five finishers (15-18) age group of the finals will receive the following:  
-> 1ST \$250, 2ND \$200, 3RD \$100, 4TH \$50, 5TH \$25
- The top five finishers (19+) age group of the finals will receive the following:  
-> 1ST \$250, 2ND \$200, 3RD \$100, 4TH \$50, 5TH \$25
- Top three youths and adults will be qualified to participate FREE OF CHARGE at Hancock County Fair.

## GENERAL RULES

- All participants must read and sign the liability waiver.
- No headphones or jewelry while on obstacles.
- No food, drinks, gum or plastic water bottles.
- All clothing and costumes must be family-friendly. At the discretion of the course judges, competitors may be asked to change or cover clothing that is deemed offensive.
- If any part of your body or any of your clothing touches the ground during an obstacle your run will be over.
- Competitors must engage the obstacle only – if you use any portion of the course not intended for competition your run will be over.
- Obstacles must be completed in order.
- Competitors must be barehanded – gloves, chalk, spray, tape and other grip aids are not permitted.
- Shoes are not required, but are strongly recommended. To avoid damage to the course, no shoes with teeth or fixed with teeth will be permitted.
- If you leave the course obstacles, platforms or walkways, your run will be over.
- The course cannot be stopped or paused once started for any reason (exceptions sudden severe weather or safety concern identified by course officials).
- Heat qualification, your time will stop when you complete the warped wall.
- Finals, your time will stop when you complete the Warped Wall and land past set mark.
- Only one person on the obstacles at a time.
- Please be respectful of other competitors and set a good example for younger competitors. Competitors engaging in distracting behavior, cat calling or heckling while other competitors are on the course, will be disqualified.
- If you require medical attention at any time while on the course, signal for help and remain where you are until medical assistance arrives.
