## CAMPER PARKING RULES

1. All Persons qualified for camping privileges. MUST HAVE PERMIT APPLICATION TURNED IN BY THE DEADLINE TO ENSURE SAME CAMPSITE AS PREVIOUS YEAR.
2. AWNINGS WILL BE ALLOWED IF SPACE AVAILABLE
3. All campsites must be kept in an orderly condition. NO OPEN FIRES PERMITTED.
4. All campers are expected to be quiet and in their camping facilities at a reasonable time after curfew.
5. All camping adults must have a Season, Membership, or Concessionaire Ticket.
6. You, as a camper, are RESPONSIBLE for any damage to electrical or water outlets at your campsite.
7. Any person who does not abide by these rules, and having premiums coming to them will forfeit all premium- due to them, and will be removed from Fairgrounds.
8. Hours that campers will be accepted for arrival are as follows:  
Thursday and Friday 5 p.m. - 8 p.m. and Saturday 8 a.m. - 12 p.m.
9. Permits will be handed out as campers arrive.
10. All camping facilities, must have a parent or legal guardian present.
11. Any electrical hookups before Thursday will be assessed an additional charge.
12. ALL CAMPERS MUST HAVE WORKING SMOKE ALARM AND UP TO DATE FIRE EXTINGUISHER
13. The Lessee also agrees to hold the lessor harmless from all damages or liability on lessee part and will indemnify The Shelby County Agriculture Society for all expenses incurred due to the lessee's negligence
